DATE OF THE TRIP:

QUALIFICATION PERIOD:

January 1 - May 31, 2026

*You will have 5 full months to qualify and earn this trip.

- At least one month during the Qualification Period.

ACCUMULATE 5,000 NEW VOLUME POINTS

New Volume Points can come from a combination of the following sources:

- **New Customer Volume**

- 1 point for every Club Point from a new Retail or VIP Customer. Only the first order placed by a new customer counts as new volume.

- **Brand Partner Enrollment Packs.**

- Volume from Brand Partner enrollment packs counts toward New Volume Points.

FLIGHTS:

Orlando International Airport (MCO)

REGISTRATION:

In the event of a cancellation, the applicable commission adjustment will be applied. If the full adjustment amount cannot be satisfied through a single commission payout, Bravenly reserves the right to deduct the remaining balance from subsequent commission payments until the adjustment is paid in full.
