

June 2027

QUALIFICATION PERIOD:

January 1 - December 31, 2026

You will have 12 full months to qualify and earn this trip.

*Starting January 1, 2026, and ending on December 31,
2026 at 11:59pm ET.*

EARN THE TRIP:

Must achieve these 3 requirements:*

- **Achieve the rank of Gold Executive Vice President** for the **FIRST TIME** during the qualification period **OR** maintain **Gold EVP** for **2 months** during the qualification period.
 - *Months do not need to be consecutive.*
- **Accumulate 10,000 total New Volume Points**
 - New Volume Points can come from a combination of the following sources:
 - **New Customer Volume:** 1 point for every Club Point from a new Retail or VIP Customer. Only the first order placed by a new customer counts as new volume.
 - **Brand Partner Enrollment Packs.** Volume from Brand Partner enrollment packs counts toward New Volume Points.
 - *Example: This includes 300 points for Business Builder Kit, 900 points for a Brave Launch Pack, 1,500 points for a Momentum Pack & 2,100 points for a Legacy Pack.*
- **Accumulate 8,000 in Mentorship Points**
 - Accumulate 8,000 total Mentorship Points during the Qualification Period. Mentorship Points are earned by supporting the rank advancement of your Personally Enrolled Brand Partners.

How to Earn Points

HOW MENTORSHIP POINTS ARE EARNED

- Mentorship Points are awarded each time your Personally Enrolled Brand Partner (PE BP) achieves a New Lifetime Rank of Director or higher during the Qualification Period
- Points are earned in the month the new rank is achieved
- Mentorship Points are awarded for new rank advancements only (not for maintaining a rank)

MENTORSHIP POINTS BY RANK ADVANCEMENT

- 500 pts: PE BP promotes to Director
- 1,000 pts: PE BP promotes to Senior Director
- 2,000 pts: PE BP promotes to Executive Director
- 4,000 pts: PE BP promotes to Senior Executive Director
- 8,000 pts: PE BP promotes to Vice President
- 15,000 pts: PE BP promotes to Senior Vice President
- 30,000 pts: PE BP promotes to Executive Vice President
- 60,000 pts: PE BP promotes to Silver Executive Vice President
- 125,000 pts: PE BP promotes to Gold Executive Vice President
- 250,000 pts: PE BP promotes to Platinum Executive Vice President

RULES & FAQ'S

TRIP RULES & FAQ'S:

- Inclusions:
 - Roundtrip airfare for two to and from the trip destination during the scheduled travel dates.
 - Luxury accommodations upon arrival.
 - All dinners and curated dining experiences.
- No cash buyout.
- Not deferrable. Non-transferable.

- Must be in good standing.

POINT FAQ'S:

- Mentorship Points accumulate across the Qualification Period.
- Points may stack if someone promotes to Director and Senior Director the same month, you earn points for BOTH rank advancements.
- Only new lifetime rank advancements qualify for Mentorship Points.
- Previously achieved ranks do not count again if re-held or maintained.

OTHER TERMS & CONDITIONS:
